Dennis-

Attached are photos of the driveway at 12 Bedle Road. The resident was not at home when we performed the site visit.

This driveway was reconstructed as part of the Beers Street Sidewalk Project a few years back. The driveway was replaced to a joint in the driveway approximately half way up the driveway. This puts a hinge point in the driveway. The only way to remove the hinge point would be to saw cut the driveway at the garage and reconstruct the driveway at a constant slope from the saw cut line to the new sidewalk. There appears to be no structural deficiencies with the driveway as installed.

It appears that the resident also utilizes the grass strip next to his driveway as a parking area. I am not sure if this was part of the complaint but the Beers Street Sidewalk project would have had no effect on this as the resident already has a double driveway.

Please let me know if you would like us to replace the driveway and we will obtain a price from S. Brothers and add as a change order to the Lammers Street project.


