

In an ongoing attempt to control costs, in late 2013 the Township Committee hired a part-time temporary Tax Collector resulting in a savings in the line item Revenue Administration (Tax Collection) - Salaries and Wages. The plan for the future is to have a current full-time employee certified as a Tax Collector and assume a dual role within the Township.

The adoption of Chapter 2 of P.L. 2010 implemented requirements for all local units to begin collecting, at a minimum, 1.5 percent of employee salaries to offset employer health care costs. The Township of Hazlet implemented a similar requirement over 10 years ago. The adoption of Chapter 78 of P.L. 2011 implemented new requirements for employee health care costs based on a combination of salary and health care premium costs. This new requirement was implemented for all employees covered on January 1, 2013. In 2014, the Township anticipates these measures saving in excess of \$200,000.00 in health care costs. The following is a breakdown of projected contributions by bargaining unit:
