Fees:    \$60.00 per section for Hazlet Residents; \$120.00 per section for Non-Residents  
Picnic fees are non-refundable.

There is a \$100.00 refundable security deposit required. The deposit is returned provided all the rules were followed. This security deposit must be a separate check.

**RULES AND REGULATIONS**

1. This Permit must be properly signed and filed with the Hazlet Recreation Commission. It is not transferable. Please have your signed copy with you while using the facilities.
2. These premises may only be used on and for the specified date and purpose.
3. The park closes at dusk.
4. Your organization will be held responsible for any disorder and/or damage done to the property.
5. All groups must clean area before leaving. All garbage and recyclables must be removed from the picnic grove(s). Removing the garbage is the responsibility of the applicant. Failure to comply will result in a deduction from your security deposit for park clean-up and your renewal of permits in future years.
6. Please be advised that there is a Township ordinance (chapter 347-8 violations & penalties) which mandates a \$100 fine for non-compliance with recycling requirements.
7. No vehicles are permitted in the picnic areas. You may unload your vehicle however it then must be removed from the picnic area.
8. No fires except in the picnic grills.
9. Alcoholic beverages are not permitted anywhere on Township property.
10. It is the responsibility of the applicant to be certain that all requirements regarding insurance, special needs, etc. have been met before the scheduled date.

Any violation of the above rules and regulations will mean revocation and/or ineligibility for existing or future permits plus loss of security deposit.
