

ALCOHOLIC BEVERAGES MAY NOT BE BROUGHT ONTO TOWNSHIP PROPERTY.

Glass containers are not permitted on any township field by township ordinance.

All garbage must be removed by the organization/league. If the garbage is not removed by the league, they will be charged for a maintenance staff member for payroll costs and overtime for the clean-up.

All national and state laws, local ordinances, and rules of the Police and Fire Departments regarding public assemblies shall be strictly complied with. Township owned facilities are governed by NJ Law N.J.S.A. 13, 8a-1, 8a-20 and 8a-35 et seq. This establishment, under NJ Law N.J.S.A. is a place of public accommodation and will extend its services and facilities to all persons regardless of race, creed, color, national origin, ancestry, marital status or sex.

Groups may, from time to time, be bumped due to conflicts with Hazlet Recreation activities.

Organization/league is responsible for leaving the field(s) in the same condition as they found it and agree to be responsible for any damages, injuries or expenses incurred by Hazlet Recreation and to indemnify and hold it harmless by reason of the use of the premises.

This permit must be used only for the specific date, time, and purpose stated.

This permit is non-transferable.

Notice of cancellation of this permit by the organization/league must be received in writing *prior to the start of the season* or fees will not be refunded.

The Recreation office must be notified within 24 hours of any cancellation of games due to rain in order to re-schedule at no extra charge. If Recreation is not notified of rained-out games, there will be a fee for re-scheduled games. **THERE ARE NO REFUNDS.**

Organization/leagues are required to have their own insurance.

Individuals causing bodily harm due to violent behavior or fighting will be held responsible. Organization/league permit will be revoked.

THIS PERMIT MAY BE CANCELLED BY THE RECREATION COMMISSION WITHOUT NOTICE IF THESE RULES AND REGULATIONS ARE VIOLATED IN ANY MANNER.

The interpretation and enforcement of this body of rules and regulations will be the responsibility of the Recreation Commission at all times. Decisions and actions made necessary by circumstances not specifically covered herein will be at the discretion of the commission.

PLAYER WAIVER/ RELEASE OF LIABILITY /INDEMNIFICATION AGREEMENT

I, the undersigned player, acknowledge, agree, and understand that:

1. Voluntarily, and of my own free will, I elect to participate as a member of the softball team and league indicated below.
2. I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players, including, but not limited to those hazards associated with weather conditions, playing conditions, equipment, and other participants.
3. I understand that sliding into base is dangerous to me and to other players and may result in serious injury or death.
4. I understand that the very nature of the game of softball is hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding, and catching of the ball, the swinging of the bat, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.

Furthermore, I, the undersigned player, agree that in consideration for the right to play as a member of the team designated below and in consideration for permission to play on the fields arranged for by the team or league:

1. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or league for practice or play.
2. I release, discharge and agree not to sue the team and league designated below, the field owner or other entity designated below, the Amateur Softball Association of America, or their owners, officers, agents, servants, associations, employees, or any person or entity connected with the team, league, field or amateur Softball Association of America for any claim, damages, costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.
