No person shall remove or destroy or cause to be or allow to be removed or destroyed any tree without first obtaining a permit from the Conservation Officer. A permit is required for all trees of four-inch (4') caliper or larger.

Existing Residential Property; If the application is on behalf of an existing homeowners association and it is disclosed that the total number of trees to be removed or destroyed on the property or open space area in question, which are the subject of the application, is ten (10) or less, the permit shall be issued without replacement trees required. Within a one year period, permits may be used for removal of no more than ten (10) trees on the same property without replacement trees being required. Any tree removal occurring where a homeowners association exists must obtain formal approval by the ruling body of the association prior to obtaining a tree removal permit.

All applicants indicate on a survey or a site plan all trees to be removed, specifically by an assigned number and caliper of each tree. Include species of trees over (4") four inch in caliper and Laurel over (1") one inch in caliper. Indicate on the plan all trees to remain specifically by an assigned number. The plan shall indicate the "Limit of Disturbance Line" i.e. where a (4') four foot high standard snow fence will be erected if required by the Conservation Officer. The plan shall indicate the reason for tree removal and the means of disposal.

Dead and diseased trees are not to be counted as trees to be replaced

Application fee for new resident building lot: Fifteen (\$15.00) per tree up to a maximum of \$300.00 per lot. For all other properties: Fifteen (\$15.00) per tree up to a maximum of \$600.00 for each acre. All Tree Removal Permits are good for one (1) year.
