RESOLUTION

WHEREAS, the Monmouth County Board of Chosen Freeholders, pursuant to N.J.S.A. 26:9-27 et seq. has elected through its Mosquito Control Division to perform all acts necessary for the elimination of mosquito breeding areas and/or to exterminate mosquitoes within the County; and

WHEREAS, the County has instituted an Integrated Pest Management Program consisting of surveillance, water management, biological control and chemical control to exterminate the mosquito population within the County of Monmouth; and

WHEREAS, prior to conducting aerial dispensing operations over a designated "congested area," the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 137.51), to secure prior written approval from the governing body of the political subdivision over which the aircraft is to be operated; and

WHEREAS, the Township of Hazlet is designated as a "congested area" by the Federal Aviation Administration and the County has requested that this governing body consent to its proposed aerial dispensing operations.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The Governing Body hereby authorizes the County of Monmouth Mosquito Control Division or its agent to apply pesticides by aircraft for mosquito control in certain areas of the municipality designated by the County as being either larval mosquito habitat or areas harboring high populations of mosquitoes constituting either a nuisance, a health hazard, or both with the understanding that:
 - a. The County shall utilize pesticides, application equipment and aircraft that are approved for aerial applications by the applicable Federal (USEPA) and State (NJDEP) agencies, and
 - b. Such operations will be performed in compliance with applicable Federal and State regulations, and

- c. The County will notify the police department of each municipality over which aerial pesticide operations are planned prior to commencement of such operations.

RESOLUTION

WHEREAS, the Township Committee of the Township of Hazlet recognizes the impact of the COVID-19 crisis and social distancing measures on bars and restaurants within the Township, and is desirous in allowing outdoor food and beverage consumption on sidewalks or other areas near or adjacent to the bar or restaurant, with limitations, during the COVID-19 emergency; and

WHEREAS, bars and restaurants must comply with all applicable Executive Orders; and

WHEREAS, the Township Committee previously adopted Resolution 118-2020 concerning outdoor areas for food and beverage consumption, and this Resolution shall supersede that prior Resolution to comply with the recently enacted P.L. 2021, c. 15; and

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of Hazlet Township hereby allows and authorizes the temporary use of private and public sidewalks, or such other property adjacent to or near the bar or restaurant for outdoor food and beverage consumption, with the limitations set forth herein.

BE IT FURTHER RESOLVED that the bar or restaurant must submit to the zoning officer: (1) a plan, sketch, picture or drawing of the proposed outdoor extension showing all tents, canopies, umbrellas, tables, chairs, and other fixtures or equipment; (2) a plan for the control of litter and garbage; and (3) consent of the owner if other than the applicant.

BE IT FURTHER RESOLVED that the zoning officer shall issue an approval within 15 business days of the applicant submitting a complete application in accordance with P.L. 2021, c. 15.

BE IT FURTHER RESOLVED that interference with fire lanes is prohibited.

BE IT FURTHER RESOLVED that safe and adequate pedestrian access to and from the bar or restaurant, and to and from all other businesses on the same property, must be maintained.

BE IT FURTHER RESOLVED that compliance is required with all applicable ADA regulations.

BE IT FURTHER RESOLVED that outdoor food and beverage consumption shall not be permitted between 10:00 p.m. and 11:00 a.m.
